Wet Spring!

Spring 2003 was one of the wettest on record. FLG member Doug Odell captured this picture (left) of the torrent of water flowing over Norton Falls on May 7th 2003. The torrential rains were also too much for Lake Glenville to accommodate, prompting Duke Power to lower the gates at Thorpe Dam, sending millions of gallons of water rushing into the West Fork of the Tuckasegee River. The official estimate of water flow from Duke Power was 900 cubic feet a second, which translates into 26 million gallons per minute. Since 1942, the gates have been lowered only four times, the most recent in 1994 when the lake was lowered to complete some automation work on the generating plant. THE PRESIDENT'S LETTER

As I write this message the 2003 season is in full swing. After the soggy, rainy final days of June and early July the fourth of July weekend burst forth with plenty of sunshine for families, visitors and members to enjoy all of the holiday festivities. If you missed the fireworks on the evening of the fourth you missed an awesome sight. Over two hundred boats, many "decked out" in various, and sometimes elaborate states of red, white and blue, gathered 'round to watch the fireworks from the lake and surrounding mountainsides. **Tom Turner's** barge, ably captained by **Stuart Hall**, led the flotilla up the lake towards the dam then back to a point near the marina cove for the nearly one hour show.

The May and June FLG breakfasts, held at the Market Basket, were well attended by over fifty members each morning. In May our guest was **Mike Butler** the attorney we have hired to represent us in the settlement and final stages of the Duke Tuckesegee River Project Relicensing. After three years of searching for someone who could advise us through the complicated and serious issues developing in the relicensing process, our member **Bob Guerin** stepped forth to recommend Mike, his former college roommate. Mike was the Federal Energy Regulatory Commission Chairman under Ronald Reagan and is now in private practice in Houston, Texas. At the May breakfast he spoke briefly about his experience and about his first FLG assignment which is to work with the Duke attorneys on continuing our present abilities to control nuisances and security on the buffer zone property around the lake. We are able to "seed" the initial legal fees using a legal fund FLG has had in reserve for several years. However the fund will need rebuilding to cover these expenses through to the final relicensing stages in 2005. A committee of Board members, **Howard Austin, Helen Cook and myself**, has developed a plan for the Relicensing Fund and we expect to launch the campaign later this month. In this newsletter **Doug Odell** presents an excellent summary of the state of the relicensing process and what issues about which we have serious concerns.. We must remember that this relicensing is a 40 year document so we are going to make every effort to get it right!

Our FLG board members and committee chairs have been very active as the season matures. David Leach and his very efficient committee including Lynn Leach and Jackie Wertymer organized the best lake clean-up day in our history. On June 14 over thirty boatloads of members cleared floating logs, stumps and debris from around and in the lake. After the hard work all enjoyed a barbeque lunch and some even won great raffle prizes, which had been donated by businesses in the Cashiers/Glenville community. Deedee Rietze with co-chair Patti Hicks can be credited with the success of our breakfasts. Future breakfasts on July 19, August 23 and September 20 will all be held at the Landings at Trillium. Deedee's committee also arranges our Annual Meeting scheduled for 9:00 AM, August 2 at the Glenville Community Center. Our speakers this year are all from Duke Power. Local Lake Manager Dale Mosteller, Lake Manager Department Head Joe Hall, and Vice President Fred Alexander will review the new Shoreline Management Guidelines that went into effect on July 1, 2003. Deedee also joins with Patti Hampton and Sue and Bill Cassidy in running our FLG logo items sales. Many new items are available this year including golf shirts, visors and tote bags. **Keith Dixon** has enlisted expert assistance from Don Hanson to initiate our lake water testing program. The necessary equipment has been purchased and we should be hearing some of the results soon. In-flow stream water testing continues, of course, and **Sharon**. Wadsworth, a "seasoned" member of the water testing committee, will head that project. Robert Luck is researching a project to protect the mid lake islands from further erosion. He reports that we will need a great deal of help from those in the community who construct shore protection so any member who can offer names please call Robert. Last but not least, Joanne Lindquist checks our P.O. Box daily for dues payments so if you have received this newsletter and have not paid your dues please do so now. Lake Cleanup 2003

What a great day it was! Saturday, June 14th saw thirty or more boats plying the lake dragging enormous trees, logs and debris to the ramp on Pinecreek Road. The excess rain from the last month or so had floated a lot of logs, trees and dangerous material into the lake where it was a hazard to boaters and fishermen. The *Friends of Lake Glenville* had advertised the cleanup day on two occasions in the Cashiers Chronicle and at the *FLG* breakfast on May 31st at the Market Basket and asked for as many volunteers as possible to come out and help keep Lake Glenville the most beautiful alpine lake east of the Mississippi.

Cleanup morning broke a little overcast but not rainy and not too hot, which made for ideal conditions for lake clearing. Friends of Lake Glenville Summer 2003

DAM RELICENSING STATUS — Doug Odell

A major mile stone was reached at the end of May 2003. After three years of defining needs, preparing and conducting studies, having discussions and lengthy negotiations, the non-legally binding Consensus Agreement was signed on May 16th by 48 organizations. The legally binding Settlement Agreement is being drafted from this Consensus document. The Settlement Agreement will be reviewed and modified and sign-off is targeted for September 15th. The Settlement Agreement will become part of the Request for License that we will live with for the next 30 to 40 years. The Stakeholder meeting notes and Consensus Agreement will be included in the Request for License as supporting information.

This Consensus Agreement was reached after three years of work, over 3700 miles driven to meetings, 480 hours of meetings and negotiations, and another 1900 hours of learning, off line issue resolution and discussions. The last day of negotiations lasted 11 hours.

Consensus for this Agreement was signed with a ranking of (1 to 5). A (1 to 3) indicated general agreement. A (4) indicated reservation(s) with the ability to write up to a 500 word description of the reservation. A (5) indicated a partial or full disagreement and filing a description of their disagreement or they were in full agreement but their organization could not or would not sign a legally binding Settlement Agreement. These reservation write ups are to be part of the filing.

The Consensus Agreement was signed by FLG with 20 Reservations. Some of these issues are interrelated. The issues of primary interest and in order of priority to The Friends of Lake Glenville have been:

- 1. Nuisance Control and Security within the Project Boundary
- 2. Lake level management
- 3. Shoreline erosion
- 4. Excessive trees in the lake (and near the docks)
- 5. Shoreline habitat management6. Lake Management Guidelines(To go into effect July 1, 2003)(To go into effect July 1, 2003)
- 7. Dock Request and Users Agreement (To go into effect July 1, 2003)
- 8. Glenville Gorge recreation releases
- 9. Habitat Protection and Environment Fund

Early in the relicensing activity, it was identified that assistance would probably be needed with the relicensing effort. A continuing search has been made for relicensing, natural resources, and/or legal consultants to guide us through the FERC process and procedures. It was difficult to define our real needs and even harder to locate the proper resources. As time progressed through this process, it became much clearer that assistance was needed dealing with the FERC procedures, creating supportable approaches and crafting the correct FERC phraseology. A Washington legal firm was located that deals with FERC and FERC issues.

With the approval of our Board of Directors, at the April 22nd meeting, we were ready to engage the firm for legal aid as a consultant. A FLG Member suggested another choice which has been pursued. Mr. Mike Butler of Houston ,TX is now providing our legal assistance. He is a prosecuting attorney for land and water use type cases. He was the Chairman of FERC during the Reagen Administration. His preliminary and information gathering phone calls had a direct and positive impact on the last days of the negotiations.

1. Nuisance Control and Security

Duke Power does not enforce nuisance controls; Wildlife Enforcement enforces fishing, wildlife and boating regulations; the Sheriff will enforce criminal laws and respond to private land owner problems. The solution to nuisances on Project Boundary land problems has been Shoreline Leases. They have worked. Duke Energy is not continuing Shoreline Leases. We do not have Project Boundary nuisance control protection after July 1, 2003. We did get a line item into the Consensus Agreement that Duke will continue to pursue a solution.

The Lake Manager did obtain an agreement from Sheriff Cruzan to enforce the laws on Duke Property. Then there was an election. The current Sheriff has not signed an agreement. This has been our prior experience and concern with this approach.

The use of a non-exclusionary lease is not a problem with FERC. This is a Duke position that is being explored by our attorney.

2. Lake Level Management

Lake levels are now described by a target level with upper and lower bounds. The Duke management statement is that they will strive to maintain the target level. Power generation – including maintaining lake levels is now managed from Charlotte. The Power Generation team has been on a learning curve this year, with mother nature providing the class room.

During the last days of negotiation the summer lake level target was lowered from 98 feet to 97 feet. This curve satisfies most of the CHEOPS model requirements. The Consensus Agreement curve is now:

In addition to the targeted lake levels there is a Low Water Protocol. When rain fall is short and the agreed to water usage can not be maintained and the lake level drops below the lower limit, the Low Water Protocol takes affect. The lake level minimum value is lowered one foot in each of six cycles. In 48 years of data the first stage of the Low Water Protocol (1 foot lower) would have been entered twice and the 2nd stage (1 more foot) would have been entered once.

There is also a Maintenance and Emergency Protocol that describes what can go wrong in the power generation operations and what actions will be taken when things do go wrong.

3. Shoreline Erosion

High water, heavy wakes and trees tipping over and ripping out the roots are contributing to the shoreline erosion. The targeted summer lake level was negotiated down to 97 feet. It has been established that when trees are showing signs of falling, they may be cut – let fall into the lake for fish habitat and tied off to secure them to the bank. This keeps the roots intact in the ground. Duke's approval is required. A workable solution was not found for controlling heavy wakes. Also the Resource Agencies were interested in establishing more habitat but were not interested in the shoreline erosion problem.

4. Excessive Trees

Up until the final version of the Vegetation Restrictions we had a clause that would allow, with approval, the control and thinning of the trees that have fallen into the lake. This condition can become excessive. A fallen tree can, with approval be pulled up into the project buffer for land habitat. Docks and dock access can be kept clear.

5. Shoreline Habitat

It has been established, after significant reiteration, that the areas posted by Duke with Wetlands signs are **NOT** U.S. Corps of Engineer designated wetlands. The areas are now called Sensitive Vegetation areas. The signs probably will never be changed. If the abutting property owner chooses to disagree with the designation – they may.

The most vegetative sensitive areas are at the stream confluences. A team, including the Resource Agencies toured most of these areas on Lake Glenville with maps showing the habitat classifications and the current property boundaries. There are a few properties that have not been able to have a dock and under the new rules they will not be able to have a dock. There are a few properties that could not have a dock but now may, with mitigation, be able to have a dock. Owners should check with Duke before dividing such properties. The July 1, 2003 property mapping will apply. Objections were raised to this short notice not but were overruled.

6. Lake Management Guidelines

Many items in the Management Guidelines have not changed and there are some significant changes. There will be much closer management of the lake and the shoreline Project Boundary. It is important to stress to the membership to discuss and get prior approval from Duke before making any changes within the Project Boundary.

The Resource Agencies would have preferred to have all of the Project Boundary reverted to deep forest conditions. It was with only hard negotiations and repeated objections over many days of effort that the Resource Agencies did not get their way. If Lake Reps had not been at the table there would have been limited access, no viewsheds and stricter vegetation requirements. There is a statement in the Agreement that prior agreements and approvals will be honored.

7. Dock Permit and User Agreement

Dock sizes and acceptable configurations will stay the same. Some types of boat lifts are now acceptable but must stay within specified dock size. The number of powered boats per private dock has increased. In some locations it will be possible to "bridge" sensitive vegetation for access to a dock.

As of July 1, 2003, it will be necessary to make a formal request and sign a User Agreement for a dock. There is one major problem with the User Agreement. The paragraph pertaining to who pays any legal fees is one sided and needs to be changed to a standard business statement

8. Glenville Gorge Recreation Releases

There are a number of concerns in addition to the use of water from the reservoir for non-generating purposes. The cost of the trail down to the launch point (\$100,000), potential parking congestion and safety at the dam, high cost of recreation for a few participants, additional costs for Rescue Squad, and potential property rights violations, etc.

SEAPLANE LANDS ON LAKE GLENVILLE

According to a life long resident of the lake who was home at the time, on Saturday July 5th 2003 a seaplane landed on the 107 side of the middle of the lake and taxied up to Admiral's Point. She reported this to the sheriff's dispatcher who asked the question "who should we report this to?". According to this resident, the sheriff's office did not come out to investigate. She also noted that the plane had extreme difficulty getting airborne due to the increased boat traffic and had to cut its engines several times due to boats getting in the way while they were attempting to take off."

It turns out that what she interpreted as cutting the planes engine because of boat traffic may have also been the pilot attempting to take off and then deciding that his seaplane was sinking. According to multiple witnesses at the Tater Knob beach the pilot stated that he came ashore because he decided he was overloaded and also because he thought he was sinking, having just

had repairs done on the hull of the seaplane earlier that week. He was apparently picking up two passengers, and their weight combined with all their Another Duke Power executive is said luggage was too much for his seaplane, given the altitude of the lake and the ambient air temperature and humidity (too little lift in thin air). After he got ashore and realized he did not have a leak, he found alternate transportation for his passengers and took off again.

A kavaker on the lake at the time reported that he got to watch the take off near the northern edge of Buck Knob, near Tom Turner's dock. It seemed to him that the seaplane came rather close to boats on the lake during the take off and was not very far above the trees on the island north of Buck Knob near the eastern shore, while admitting that he was not a pilot and understood there are problems judging depth of field at a distance. At least one lake resident is said to have reported this incident to the FAA, complete with tail numbers.

When the lake manager for Duke Power was reached, he is quoted as saying that at least 17 other people had called about the plane, including the initial observer mentioned above. to have noted that Nantahala used to "prosecute to the fullest extent of the law" for that type of thing.

An older neighbor who had been a pilot said: "Years ago we had several planes on the lake. They were banned by Nantahala Power. A while later I checked the aeronautical charts. Lake Glenville was shown as Restricted - don't land except for emergencies. I haven't checked recently haven't been doing much flying lately."

At the time of publication, the name of the pilot and any follow up action by Duke Power, local law enforcement, or the Federal Aviation Administration is not available. Additional information may be available in the future from one of those agencies, as well as the Crossroads Chronicle. 9. Habitat Protection and Environment Fund

A Habitat Protection and Mitigation fund was proposed and finally included in the Consensus Agreement. A number of expensive projects were proposed – totaling \$11,000,000. But none of the proposals contained definitive evidence of degradation to the environment by Duke operations - only generalities. Duke had worked diligently to identify problems caused by their operations and to correct or mitigate the problems.

The Jackson County Manager proposed a county approach which would add compensation to Dillsboro for removal of the Dillsboro Dam, expansion projects for Andrews Park and a section of Greenway trail from Dillsboro to Cullowhee along the river. Rights of way exist.

The County Manager's approach was supported by FLG. And, the County Manager supported FLG for nuisance control, lake shore erosion control, and excess trees in the lake.

FLG Water Quality Testing Program Expands Its Charter

Volunteer samplers and couriers are continuing their efforts to monitor the seven primary streams that enter Lake Glenville. Seven different samples are taken each month at each location and delivered to UNCA for analysis. The tests include acidity, alkalinity, turbidity, total suspended solids, conductivity, heavy metals (copper, lead, and zinc), orthophosphate, nitrogen, and ammonia.

Tests continue to show an over all high quality water in all of our streams.

The annual 2002-2003 comparison report is due shortly and will be posted on the FLG web site and available at the annual meeting.

Lake testing equipment has been purchased and preliminary tests have begun on the lake itself at six different locations. We will compare turbidity, acidity, and temperature at different depths.

Initial tests by member Don Hansen indicate lake turbidity levels in the 1-2 NTU range which is quite good, and actually less than our streams. Turbidity seems to be greatest at near-surface layers. Below that the turbidity is very low and the water is considerably more acidic. Since there has not been much evidence of shoreline erosion or resuspension of unconsolidated sediment by surface waves, we speculate that this early season turbidity is biogenic.

TALK TO DALE

The updated Shoreline Management Guidelines became effective on July 1 2003. Before cutting trees or trimming bushes or doing almost anything within the Project Boundary (below the 3110 line), read the new guidelines and - **Talk to Dale**. Before planning to install a dock – **Talk to Dale**. If you have trees in the lake that are unwanted – talk to Dale. If you plan to divide a lot or file a plat and plan to install docks – **Talk to Dale**.


