# PRESIDENT'S CORNER

Old man winter tightened his grip on the lake and surrounding communities throughout January and February. Along with several snowfalls, including two in April, temperatures plunged during one episode to 0 degrees and even below -4 degrees at some areas around the lake. Nevertheless the wintry grip usually loosened after several days to make way for sunshine. Now with mild temperatures in the 60's and 70's and rising lake levels, we know spring is just beyond the clouds!

*Friends of Lake Glenville* committees and chairs have been accomplishing projects over the winter, planning and preparing for our members return to the lake and the 2003 Season. Treasurer **Joanne Lindquist** mailed 2003 dues letters in early February explaining that our fiscal year is now January 1st to December 31st..... a much more sensible way to keep our records and for members to know when dues are due. Also, all dues and sponsorship levels were raised slightly by the Board. When you pay your dues and/or sponsorship, please remind yourself to encourage a non-member Lake Glenville neighbor or friend to join as well. Our membership increased approximately 10% in 2002 but still short of our *Double-the-Membership* goal.

**Deedee Rietze** and her social committee are finalizing the dates and locations for the FLG breakfasts. The first one of the season is scheduled for Saturday, May 31st, and these Saturday morning events will continue each month through September. Deedee promises more information soon about the Sundowner, which is scheduled for July 12.

When you ride through Glenville on Highway 107, you will notice a great improvement to the post office roadside garden. **Gale Crawford** and **Keith Dixon** teamed up to get the area cleared and planted with low maintenance but attractive shrubs. *Friends of Lake Glenville* signage will identify our organization as the contributor and serve as a welcoming greeting.

Secretary **Helen Cook** is working with me to update our archives and organization records. The history and documents held in volumes since the group was founded are an important aspect of any organization for historical perspective. In addition Helen has assumed the FLG public relations function to enhance our image and increase community awareness.

Chair **David Leach**, co-chair **Lynn Leach**, and their committee have set June 14th for the spring lake clean up...scheduled earlier this year as requested by our participating members. Not only does this activity help to fulfill our organization's mission as good stewards for the lake, it can be a wonderful family activity, so please plan to gather your "man power" and join the lake clean-up crew. Detailed directions and instructions will follow as we approach the date.

Our lake representatives of the *Tuckesegee Relicensing Stakeholders Team* are entering the third year of monthly meetings working with Duke Power officials, state, county and federal agencies, and recreational advocate groups to reach agreement on the 50-year management plan for the lake and river basin. Besides monthly meetings several members of our lake group are assigned to technical leadership teams that discuss and settle issues such as shoreline habitat guidelines, shoreline management and recreation use and needs. Stakeholder team members **Phil Fowler**, and **Helen Cook** have traveled monthly from Florida and **Doug Odell** from Tennessee to avoid missing any of these important meetings. **Jackie Cochran** even managed to keep her attendance record perfect last year despite a broken foot. I have traveled from Atlanta during the winter months to keep my perfect record of attendance at these meetings. In addition to attending the *Tuckesegee* meetings, each month Doug Odell has attended two other stakeholder groups, *Nantahala* and *Tapoca*, as an observer to better understand the process and how to apply that knowledge to the negotiations in which we are involved.

Areas now in final negotiations for the lake and the river basin include issues such as lake levels, recreational releases, wetlands designations, recreational improvements, shoreline management and protection. Although we are aware that any of our negotiations can result in either a win, lose or draw, we are prepared to use every resource available to achieve the result that is best for the lake and the community at large. Any of the stakeholder team members can provide you with more details, and the team will present briefs at our monthly breakfasts.

# Lake Cleanup 2003 & Boating Safety

Hello Everyone! Hope you have all had a wonderful few months off the water, those of you who do not use the lake year-round. Let's get you up to speed on activities and issues for 2003 in the Boating Safety and Recreation department:

## Lake Clean-Up

Mark your calendars for **Saturday, June 14 from 9:00 a.m. to 1:00 p.m.** Let's do even better than last year. The details are on the website at [www.friendsoflakeglennville.com](http://www.friendsoflakeglennville.com). There will be a presentation and handout at the FLG breakfast on May 31st at The Market Basket in Cashiers. Do come to the breakfast so we can be sure everyone is on the same page. On the day, please bring along all your guests and friends and remember: you do not have to be a member of FLG to participate. We all use the lake, regardless of membership so let's all turn out and help keep our lake the most pristine in the whole United States. We will be serving a free lunch from 1:30-3:30 pm to all those who participate in the clean-up, at the Pavilion at Buck Knob Landing (many thanks to Tom Turner for the use of the Pavilion and to Jackie Wertymyer and Ann Killilea for arranging lunch.). Please come by and socialize. We need to have a count of those who will be coming by so if you intend to do so, please call me on 828-743-1825 or 770-475-2155 or email me at [leachga@earthlink.net](mailto:leachga@earthlink.net). Let me have your name and how many people will be coming for lunch. Only those who participate, please! I will also pass round a sign-up sheet at the breakfast on the 31st.

## Fireworks on July 4th

I know we all enjoyed the fireworks display last July 4th immensely. Tom Turner is once again loaning his barge for the event (many thanks, Tom.) We are working with Stuart Hall, who was in charge of setting off the fireworks last year, to see if FLG will participate as the major sponsor this year. We need to find a licensed pyrotechnics expert who can set off the fireworks so if anyone knows of such a person, please call me a.s.a.p. Current plans are as follows: Boats will assemble on July 4th at 7:45 p.m. between Buck Knob Island and Buck Knob Landing. At 8:15 p.m. we will proceed up the lake towards the dam behind the barge, around the small island, and back around Buck Knob Island to the firework station off the Marina. The event will begin at around 9:15 p.m. and end at around 10:00 p.m. Stay tuned for more details later. Rainout date will be Saturday, July 5th.

## Boating Safety Courses

Boating safety courses are held at the Cullowhee or Sylva Fire Departments and are taught by the Officers of the North Carolina Wildlife Resources Commission. The course currently posted on their web site for this year are is June 10th 9:00 a.m. to 3:30 p.m. at the Jackson County Rescue Squad Building in

Sylva, behind the Old Court House. Others may be posted during the summer. Check at their website [www.ncwildlife.org](http://www.ncwildlife.org), select *Boating/Waterways*, then *Safety* at the top, then type in *Jackson County*. We are also looking into holding a course in Cashiers or Glensville during the summer and will advise you of this via the website or at the breakfasts.

I encourage you to have anyone who wishes to operate a Personal Water Craft (PWC i.e. Jet Ski) to attend this course, which is an approved boating safety course as defined below. **Under current North Carolina law, no one under the age of 12 may operate a PWC. Those between 12 and 16 may do so only if they are accompanied by a person 18 or older OR have a Boater Safety Certification Card issued by the Wildlife Resources Commission OR proof of other satisfactory completion of an approved boating safety education course and have ID showing proof of age.** Those over 16 may operate a PWC without such a course or proof of age.

## Lake Signage

I believe all the *Danger* and *No Wake* signs are in place on the lake. Please let me or any FLG Board member know if a sign is ever removed or damaged. We will advise Wildlife who will replace it.

The FLG Board has been seeking to have signage erected at the two public boat ramps on Pinecreek Road that would provide much more information to the boating public. These signs would be three-sided, one side each for Wildlife, Duke Power and FLG. The FLG side would contain information/leaflets on boating safety regulations, the newsletter, boating courses and other information for the general public. We will keep you informed of our progress in getting this signage installed.

## Meeting with Sheriff Ashe

Carol Adams and I had a very good meeting with newly elected Sheriff Ashe on April 22nd to introduce our organization to him and discuss areas of mutual interest such as lake and shoreline law enforcement. We will inform you of the details of this meeting at the May 31st breakfast.

We look forward to another year of safe activities on our beautiful lake. Let's all try and get more members to join FLG. The more members we have the greater the chance of maintaining our unspoiled environment.

[Editor's note: A new federal boating rule requires **ALL children 12 years of age or younger to wear a Coast Guard approved personal flotation device (PFD) whenever a boat is under way.** NC Wildlife will be enforcing this rule as well as all other Coast Guard and North Carolina boating laws.]

# DAM RELICENSING STATUS — Doug Odell

The Technical Leadership Teams (TLT's) that have conducted the technical studies and the negotiating meetings, The Tuckasegee Stakeholders, were supposed to have their work completed by this past December. Three of the key studies were not completed as planned, so the negotiations were delayed. To recapture the fixed end point schedule, the Stakeholders have been meeting twice a month since December. The preliminary results of the last study to be completed were received last week. Negotiations are targeted to be completed in May 2003.

When the detail work is completed in May, the information will be put into smooth form for review. Final review and agreement is targeted for September 2003. The License Application is being drafted and must be submitted to the Federal Energy Regulatory Commission (FERC) by July 2003. FERC will then review the application and hold Public Comment Sessions. The current license expires in July 2006.

Work has been completed for several of the studies such as Cultural, Aesthetics and Communications. The larger and more difficult areas are Water Flows, Water Usage, Recreation Needs, and Wildlife Habitat Protection (primarily aquatic habitat).

**CAUTION:** *Negotiations are still in progress. Details of the topics discussed here can change until a consensus agreement is signed. However, it is important that you are aware of the types of items are being negotiated and have an idea how the negotiations are progressing. The details can change until September.*

## Lake levels and Water Flows

One of our main concerns is maintaining acceptable lake levels. Lake level is dependent on amount of inflow, retention time, and outflows. Inflow is dependent on mother-nature and rainfall. Outflow is dependent on usage for power generation, downstream needs, aquatic habitat flows, and recreation.

Lake levels on Lake Glenville, in the West Fork, are dependent on the East Fork operations and lake levels and the downstream needs. The East Fork has a large watershed that feeds relatively small lakes (Cedar, Bear and Wolf) and their respective generators. Lake Glenville, a larger lake, has a relatively small watershed but has a very efficient 1200 foot drop to the generator. The Tuckasegee Complex is operated to take advantage of the strengths of each of its parts.

Consideration for the lake levels included protection of fish spawning during the spring "bring up" of the lake; the early summer maximum levels; the summer levels and generation needs; the late summer "dry" period and the fall "draw down" level.

A tentative agreement for the target lake levels with an operational band of plus 1 foot and minus 2 feet has been reached. The figures shown are for the first day of each month. The numbers are relative where 100 = full pool i.e. "spill level". October has been the most difficult level to establish because of being in the dry period and the start of fall "draw-down".

Forty years of inflow and lake levels history is used in a hydro-model to determine the affects of proposed operations and water uses. Lake levels are only part of the story. The key issues become the usage priorities, and the most difficult part is what happens in dry years and establishing a dry year protocol. When there is not enough water coming into the lake, who gets to use the water and how much water? As there is less and less water, how does the pain gets distributed. These issues are under discussion.

Discussion is also continuing about the amount of water to be released for habitat improvement in the dam-to-powerhouse by-pass and if water will be released for kayaking recreation in the by-pass.

## FLG Stream Water Testing Program Continues...Despite The Winter...

"Whether rain, sleet, or threat of snow" your FLG water testing program continues through the winter. And, the volunteer testers can't pick a nice sunny day because the water samples are due for delivery to UNCA the fourth Monday of every month. Water samples must be taken no more than 48 hours prior to that, so the "window" for testing is quite small.

Thanks to local member volunteers Bill Linquist, Sam Lupas, and Sharon Wadsworth this year's program has gone on schedule through the winter months, and the continuity and integrity of our reporting remains uninterrupted.

Test sites range from fairly accessible (near bridge locations) to very remote sites such as Grassy Creek, an Upper Norton Creek tributary, which is one mile off US Hwy 64 through some heavy terrain.

As chairman of this very important project, I am happy to report that the winter quality results remain excellent, in most cases better than prior year. However, we must always be on guard for some dramatic or catastrophic event and we must realize that year to year differences in rainfall can affect the statistics. One thing that seems evident is that our beautiful lake is presently not being adversely affected by its incoming sources.

I must point out; however, this is just the beginning of the equation. What "man" does to the lake after the streams fill it with pure water depends upon each and everyone one of us.

By the spring issue of the newsletter we will have our first year to year comparisons. The data will not only compare our year to year results, but it will show how we rank with other North Carolina testing programs. ### Letters to the Editor

I keep re-reading Keith Dixon's article [*Sedimentation: Is it Lake Glenville Enemy #1*] in the Fall issue of [the FLG newsletter] and can't agree with it more. I have lived on the lake for the past five years in the Pine Creek area and can't believe the erosion of the lake that I have witnessed.

During the summer months it is nearly impossible to swim in the water because of the turbidity of the water caused by speeding boats, water skiing, and pulling of people on inner tubes. These people have no respect for people in small boats, swimmers, docks or anything else that is in their way. The skiers even jump over the many trees that have fallen into the water due to the erosion. I've seen that it is usually caused by the people on the lake

(home owner or long term renters) not the ones that launch an occasional boat.

With the growth going on in the area can't something be done to preserve the lake before it gets away from us? Could we establish no wake zones, reasonable lake levels, speed/skiing controls? I know that the preservation of Lake Glenville is the number one priority of the *Friends of Lake Glenville*. Don't you think it is time to take a more direct approach to our problem? Lake Glenville is too pristine to let it become another Lake Toxaway or Lake Okeechobee.

### **Downstream Recreation**

The recreation water needs on the Tuckesegee main stem below the junction of the East and West Forks have been addressed by the rafting, kayaking and fishing interests. These interests have agreed to the timing and volumes of water to be released for their recreations activities.

The timing for recreation releases does not match Dukes peak power needs, but Duke has worked with them and has established generation schedules to support their activities. The power generating schedules also support the negotiated lake levels.

### **Recreation Facilities and Needs**

The Recreation Needs study team has made their recommendations and these results are being negotiated. The recreation projects have been prioritized with initial cost estimates. A large percentage of the projects have been initially accepted. The projects for Lake Glenville include several key improvements:

1. Wildlife boat ramp areas. Adding trash collection, restroom facilities, parking area paving and barrier-free fishing docks;
2. Picnic tables and parking with barrier-free trail to a bank fishing pier at the dam recreation area;
3. Boat accessible camping at Andrews Park; and
4. Reconfigure entrance to one of the Wildlife ramps

### **Habitat Protection**

The Natural Resource Agencies have a strong interest in by-pass aquatic habitat improvement and shoreline habitat protection and improvement within the Duke Energy Project Boundary. The Project Boundary is the property between most of the private properties abutting the lake and the full pool level of the lake, that is from full pool to the famous 3110 line which is 10 vertical feet above full pool.

One of the TLT's has established seven classifications of shoreline habitat. These classifications are for that area from full pool to the lower water line. The locations of these habitat types were mapped, with the Project Boundary also being shown on the map. The existing dock locations are indicated. The locations of sensitive vegetation areas – those that have had “wetlands” signs placed on them – are indicated. These maps are part of the Shoreline Management Plan needed for relicensing.

Another TLT used the identified shoreline classifications to establish Shoreline Restrictions for protecting the habitat in the Project Boundary area at and above full pool. The seven classifications were combined into 4 categories for describing and writing the Restrictions. These Restrictions are being discussed during the current negotiation meetings. We should anticipate closer management of the Project Boundary.

### **Shoreline Management Guidelines**

The existing Shoreline Management Rules are being updated to include and reflect the Shoreline Management Plan which is part of the Relicensing effort. The lake representatives to the Stakeholders have been meeting with Duke Power and reviewing the Shoreline Management Guidelines. There will be changes primarily in the management of the Project Boundary. The basic procedure for requesting a dock permit will be the same. It will be more formal and will probably include the use of a Users Agreement. Duke is trying to have these Guidelines ready for use by July 1 of this year.
