CASHIERS LIBRARY HOSTS FLG WATER QUALITY TESTING PROGRAM

On display boards at the Cashiers Library, the general public has been able to visually see the efforts of the water quality testing program of the *Friends of Lake Glenville*.

Poster boards depicting the methods used for the tests and the complete program highlights illustrate the intensive efforts of FLG volunteers to assure that Lake Glenville remains pristine. This information is also available in total on the FLG website, updated twice yearly.

The display boards will be on display at all FLG events to enlighten members on current findings.

In addition to the seven stream testing program (inputs to Lake Glenville), certain lake testing is being considered. This additional testing will depend upon the ability to fund testing equipment and to recruit volunteers to keep the program active.

The current yearly budget of the water testing program has been approved for the year 2002.

Carol Adams is wearing many hats in our organization. She is our representative to the Stakeholders Group. This is a group that is meeting regularly with Duke Power to give input in the federal relicensing of our lake and dam. She is also the driving force behind our membership campaign. If you have not paid your dues yet this year, Carol or one of her committee members will be in touch with you soon. Her other responsibilities include fund raising, advertising in the newsletter, reviewing and recommending changes to the bylaws, and she is your vice president.

The water quality of the lake is of interest to everyone. The Friends of Lake Glenville have undertaken a Water Quality Program. Even though we feel that our water quality is "pristine", we want to monitor it and keep it that way. The project is being spearheaded by Keith Dixon. This is a monthly testing of the water that is flowing into the lake from 7 creek sites. These samples are taken to UNC-Asheville for testing. Volunteers are needed to help Keith with this project. For results of the tests be sure to visit our website or visit the public library to see the results on display boards.

Keith is also our webmaster and is constantly making improvements to our web site. We are getting over 30 hits a day and the numbers keep increasing. If you have not yet visited us on the web, do it soon, you'll be surprised at the information available about your lake. Suggestions on improvements you would like to see are always welcome. Federal relicensing of the lake and dam is probably the most important concern of our organization. Doug Odell is attending the relicensing meetings on your behalf and is also a member of the Stakeholders. He is unselfishly putting in many hours to attend these meetings. The water in our lake is a desirable commodity to others downstream. Others such as rafters and fishermen are requesting that more water be released to accommodate their sports. Of course we have no problem with the proposals to release more water as long as the level of Lake Glenville is maintained, and the recreational value is not adversely affected. Soon, Duke Energy will be sending out a questionnaire to lake residences at random. The input from the questionnaire is very important to Duke and the relicensing process. Please fill it out and return it ASAP. Duke needs to know how the lake is used by its residences. This is very important.

Our first Member Breakfast will be on May 25th at Trillium Landings. The breakfast will start at 8AM and we will have an interesting program beginning at 8:30AM and ending at 9AM. Come by boat or car, meet your neighbors, all are invited, and your comments and questions are welcomed.

- *UNC-A charges \$400 per year per test. We test seven areas and have in the past done some miscellaneous random testing. We may want to extend that this year. (perhaps even a lake test or two).
- **Covers the cost of volunteer transportation of the samples to Asheville each forth Monday of the calendar month.

"Boat Friendly"

- ♥ Be aware of, and obey, the North Carolina laws of boating.
- ♥ Personal watercraft (jet skis) should observe the rules like any other watercraft.
- ♥ Slow to 5 mph if within 200ft. of boats, swimmers, fisherman, or docks. When "in doubt", slow down!
- ♥ YOU are responsible for the wake that your boat is throwing and should consider the consequences to others (i.e. dock damage, capsizing small craft, and bank soil erosion)
- ♥ Always "give way" to (pass behind) non-powered boats such as sailboats, kayaks, canoes, and rowing craft. (200 ft. a good gesture).
- ♥ Ski and raft towing boats should never go beyond 100ft. of their disabled skiers and have an observer aboard as well as a driver.
- ♥ Keep noise within its proper perspective. Sound carries a long distance on water. Keep radios and recorders at a low volume.
- ♥ Pick up any "man-made" trash or litter you see floating in the water.
- ♥ Always stop and offer assistance to stranded boaters.

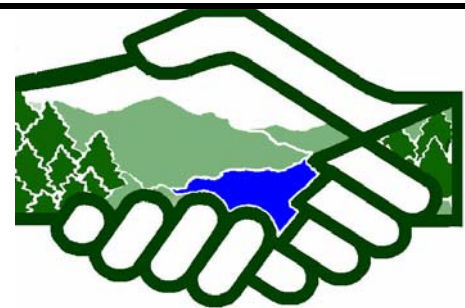

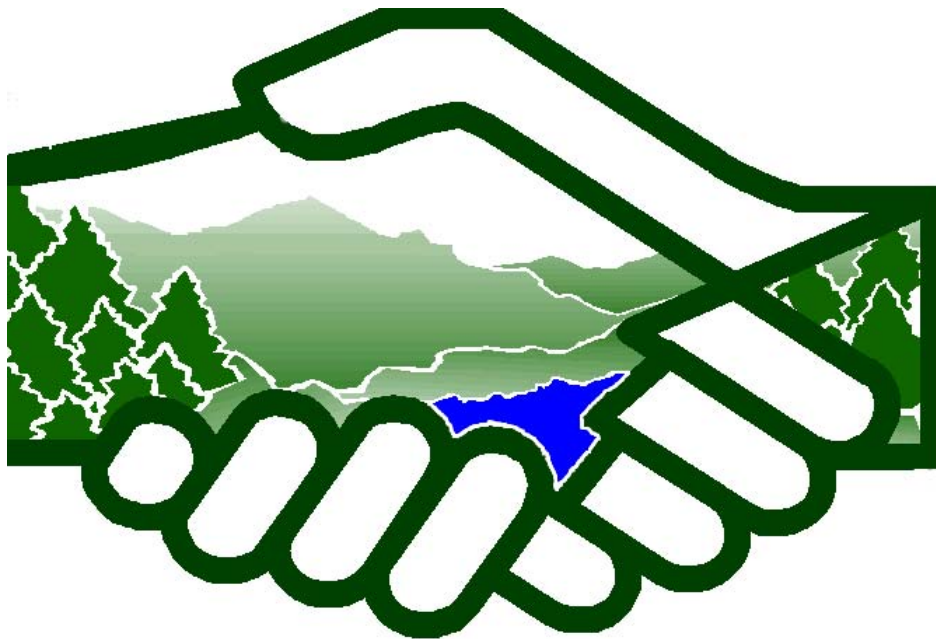
